Accreditation of TOTAL GAMEZONE XTREME, INC. ("TGXI"), a 100% owned and controlled subsidiary of LEISURE & RESORTS WORLD CORPORATION, as an Electronic Games System ("EGS") Service Provider.

Background/Description of the Disclosure

PAGCOR has approved and issued in favor of TGXI the Notice to Commence in relation to its electronic gaming system offering as an EGS Service Provider duly accredited by PAGCOR with its electronic gaming service brand, Gamezone.

TGXI has officially launched its own electronic gaming system and remote gaming platform.

As most businesses switch to a work from home scheme, and social distancing protocols being imposed due to the Covid-19 pandemic, LRWC also strives its way in this new normal by continuing to provide services to its customers through TGXI's remote gaming platform.

The electronic gaming system and remote gaming platform were initially launched on July 15. It aims to provide players with a safe and convenient platform wherein players can play anytime, anywhere. The electronic gaming system and remote gaming platform are also available on several land-based gaming sites of TGXI.

The platform is accessible to all duly registered players of TGXI and offers a variety of game options provided by Habanero, CQ9, Pocket Game Soft, and Playground Technology. Additional new games are also coming along the way.
