Clarification of News Report

This is in response to the Exchange's request for clarification of a news article published in The Philippine Star dated October 16, 2023. The article reported in part that:

"MANILA, Philippines - Listed retail gaming provider DigiPlus Interactive Corp. is hopeful it can jumpstart its \$500-million casino project in Boracay Island with Macau-based Galaxy Entertainment Group Ltd. with a government more receptive toward casino development.

The local company is determining the "comfort level" of its foreign partner to push for the construction of the planned integrated casino development in the island destination, Bacolod City Mayor Alfredo 'Albee' Benitez said in a briefing with reporters over the weekend.

'That is exactly what we are asking: what will it take for you to come back in again? It is just a matter of getting your comfort level high enough to come back,' he said.

Located on a 24-hectare property in Boracay Island, Benitez said the minimum investment should at least be \$500-million - as required by the Philippine Amusement and Gaming Corp. (PAGCOR) - for the integrated casino resort development.

However, he said the challenge is to bring back Galaxy Casino as DigiPlus partner for the project.

Benitez said initial development - such as land preparation - had already been completed in the location.

'In fact, all the plans and designs are already finished, so we're not back to square one,' he said."

We wish to clarify the statements made by Bacolod City Mayor Alfredo "Albee" Benitez, founder and former director of DigiPlus Interactive Corp. (DigiPlus), formerly known as Leisure & Resorts World Corporation. Mayor Benitez has stepped down from the Board of Directors of DigiPlus since 2021.

Please be informed that DigiPlus has no imminent plans to pursue the development of its 24-hectare property in Boracay Island into an integrated casino project. DigiPlus will remain focused on executing on its strategic transformation agenda and establishing itself as one of the fastest-growing, most innovative, and technologically developed digital entertainment groups in the Philippines.

The Company will continue to grow its digital entertainment segment, which has become its core business since 2022. It will continue to scale up its flagship digital platforms BingoPlus and ArenaPlus and at the same time, launch new and innovative digital entertainment offerings in the coming months.

We trust that this clarifies the above-mentioned news articles.
