Clarification of News Report

This is in response to the Exchange's request for clarification of a news article posted online on insiderph.com on 4 May 2026. The article reported in part that:

"DIGIPLUS Interactive Corp., the online gambling leader chaired by tycoon Eusebio Tanco, is in talks to acquire billionaire Ramon S. Ang's Diamond Hotel Philippines in line with plans to transform part of the historic Manila Bay site into a \$1 billion gaming complex.

The company has offered a multibillion-peso investment for the property, which was built by Japan's Shimizu Corp. and operated by a Japanese group in 1992 before being acquired by Ang, the chair of CEO of San Miguel Corp., as part of his private portfolio, several insiders confirmed.

DigiPlus, behind popular gambling platforms such as BingoPlus and ArenaPlus, has been lining up financing for the transaction.

Recent talks have centered on pricing, with the potential deal giving Ang a windfall over his purchase price, although one insider said he has rebuffed several offers for the five-star hotel, which sites on a a seafront lot with with (sic) 480 rooms.
